to Bank 131 Joint Stock Company, having its registered office at 420012, Russian Federation, Republic of Tatarstan, Kazan, Nekrasov St., 38 (hereinafter referred to as the Bank), consent to the processing of my personal data using automation tools and (or) without using such tools in accordance with the requirements of the Federal Law of 27.07.2006. No. 152-FZ "On personal data" (including collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, depersonalization, blocking, deletion, destruction, transfer (provision, access) and assignment of processing to third parties, the list of which is posted on the Bank's website at the link [www.131.ru/legal/pdProtection](http://www.131.ru/legal/pdProtection) ("List of third parties who process personal data of clients on the basis of agreements concluded by them with Bank 131 JSC, consents of clients") (hereinafter referred to as "Third Parties")).

The list of personal data provided to the Bank for processing: last name, first name, patronymic; year of birth; month of birth; date of birth; place of birth; gender; citizenship; details of the identity document (type, series, number, by whom and when issued), address of registration at the place of residence; address of the actual place of residence; financial and marital status; details of the migration card; information on income, place of work; period of service; position; TIN, passport details, number of the insurance certificate of compulsory pension insurance, telephone number; email address, information on the availability of bank accounts.

The personal data specified by me is provided for the purpose of considering the possibility of the Bank of concluding agreements with me and their further execution, if concluded, as well as for the purpose of:

- coordination of terms of contracts and agreements with the Bank;
- carrying out verification of the reliability of the data provided by me;
- provision by the Bank of information on the execution of contracts and ongoing account transactions;
- transfer of personal data to the Bank's counterparties in order for the latter to offer me goods, works and (or) services or to inform me about their activities aimed at promoting goods, works and (or) services;
- communication with me for the above purposes, including with the participation of Third parties;
- ensuring that my rights and legitimate interests as a personal data subject are respected, if I have authorized a representative to represent my interests in relations with the Bank.

This consent to the processing of personal data is valid from the moment of its signing and for the entire duration of the contractual obligations (in case of conclusion of the relevant contract / agreement), as well as for 5 (five) years after the date of termination of contractual obligations

between me and the Bank. In the absence of contractual obligations between me and the Bank, this consent is valid until the purpose of processing personal data is achieved.

This consent may be revoked in accordance with Clause 2 of Article 9 of Federal Law No. 152-FZ dated 27.07.2006 "On Personal Data" by submitting an application to the Bank in simple written form, or by sending this application by registered mail by Russian Post to the registered office of the Bank, while the Bank has the right to continue processing personal data, if there are grounds specified in clauses 2-11, Part 1, Article 6 of Federal Law No. 152-FZ dated 27.07.2006 "On Personal Data".
