No. 152-FZ "On personal data" (including collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, depersonalization, blocking, deletion, destruction, transfer (provision, access) and assignment of processing to third parties, including the list posted on the Bank's website at the link www.131.ru/legal/pdProtection ("List of third parties who process personal data of Clients on the basis of agreements concluded by them with the Bank, consents of Clients") (hereinafter referred to as "Third Parties")).

The personal data provided by me is provided for the following purposes:

- coordination of terms of contracts and agreements with the Bank;
- conclusion and fulfillment of contractual obligations;
- providing information on the execution of contracts and ongoing account transactions;
- ensuring compliance with laws and other regulatory legal acts, including regulations of the Bank of Russia;
- transfer of personal data to the Bank's counterparties in order for the latter to offer me goods, works and (or) services or to inform me about their activities aimed at promoting goods, works and (or) services;
- carrying out verification of the reliability of the data provided by me;
- communication with me for the above purposes, including with the participation of third parties;
- ensuring respect for rights and legitimate interests of the personal data subject who has authorized a representative to represent his interests in relations with the Bank.

This consent to the processing of personal data is valid until the Bank receives my written application for revocation of this consent. In case of termination of contractual obligations between me and the Bank, the consent does not terminate, and is valid from the moment of its signing and applies to the entire period of existence of contractual obligations between me and the Bank, as well as for five years after the fulfillment of contractual obligations. In the absence of contractual obligations between me and the Bank, this consent is valid until the purpose of processing personal data is achieved.

I agree to the processing with or without the use of automation tools of the following personal data: last name, first name, patronymic; year of birth; month of birth; date of birth; place

of birth; gender; citizenship; details of the identity document (type, series, number, by whom and when issued), address of registration at the place of residence; address of the actual place of residence; financial and marital status; details of the migration card; information on income, place of work; period of service; position; TIN, passport details, number of the insurance certificate of compulsory pension insurance, telephone number; email address, information on the availability of bank accounts.

If I revoke my consent to the processing of my personal data, the Bank has the right to continue processing of personal data necessary for the execution of contracts concluded with me, as well as in other cases provided for by law. I am aware that this consent may be revoked by me by submitting an application to the Bank in written form.
